2) Work Health Safety

The following WHS Issues were reported.

• It was reported that Perimeter Road has three patches that require repair. Council advised that these patches will be filled with gravel.

Action: Council to patch Perimeter Road

- It was advised that there is a lot of snake activity at the Aerodrome. This was discussed, and it was decided that people be informed of this activity when they are inducted into the Aerodrome.
- It was reported that debris on the runway had increased. Council advised that this information was noted, and inspections would be increased.
- It was advised that runway 11/29 requires water. This was discussed, and it was decided that this infrastructure should be added when the appropriate funding stream becomes available.
- It was requested that the Aerodrome Evacuation Plan be emailed to the Committee.
