**PUBLIC EXHIBITION - DRAFT DEVELOPMENT SERVICING PLAN FOR WATER
SUPPLY AND SEWAGE**

Narromine Shire Council resolved at its Ordinary Council meeting held 9 September 2020 to place the Draft Development Servicing Plan for Water Supply and Sewage on Public Exhibition for a minimum of 30 days. Copies of the document can be downloaded from Council's website.

A Development Servicing Plan (DSP) details the water supply, sewerage and/or stormwater developer charges to be levied on development areas utilising a water utility's water supply, sewerage and/or stormwater infrastructure.
