Executive Summary

The purpose of this report is to adopt the Social Plan 2019/2021.

Report

At Council's Ordinary Meeting on 12th May 2019, it was resolved that the draft Social Plan 2019/2021 be adopted and placed on public exhibition for a period of 28 days.

The Draft Social Plan (**see Attachment No.1**).was placed on Council's website and Facebook, as well as hard copies distributed to five (5) locations within the Shire for public viewing. Submissions closed on 15 May 2019.

Council did not receive any submissions.

The Draft Social Plan 2019/2021 identifies the hopes, aspirations and gaps within our Local Government area that influence people's quality of life.

The draft plan includes a number of phases being:-

1. Developing the Community Strategic Plan
2. Social Plan 2020

Themes within the draft Social Plan are:-

2. REQUEST FOR LEASE OF TRANGIE DOCTORS SURGERY- TRANGIE ACTION GROUP

Link to Strategic Plan:	This report relates to item 1.1.06.01 to collaborate with government and other health service providers to ensure that high quality health care facilities and services are available to Shire residents. Item 1.1.10.10 to support programs for the aged in the community with a healthy lifestyle focus.

Executive Summary

This report provides Council with the details of a request from the Trangie Action Group to utilise the Trangie Doctors Surgery to encourage Allied Health, Medical and other Health related professionals to Trangie.

Overview

The Trangie Action Group would like to make an application to become the lead tenant for the Council owned Trangie Doctor's Surgery. The Trangie Action Group would like to explore the potential for the Trangie community to generate interest from medical and health professionals to visit Trangie on a regular but casual basis to service the local community and assist the community with services such as mental health support, Allied health and other health care including chiropractic care, and podiatry.

2. REQUEST FOR LEASE OF TRANGIE DOCTORS SURGERY- TRANGIE ACTION GROUP (Cont'd)

This would not include care provided by the General Practice surgery now at the Trangie Multi-Purpose Health Service.

Report

From August 2018 the Doctors Surgery at 61 Dandaloo Street in Trangie has been vacant as the Western NSW Local Health District transferred the surgery to the Multi-Purpose Health Service located in Harris Street, Trangie.

It is also clear that there is an existing cohort of Health Professionals that are servicing the area and Trangie in particular and are utilising available rooms in private businesses, renting commercial premises, utilising government agency spaces and making do in surgery accommodation that may not be suitable.

In order to improve the business accommodation needs and to potentially welcome more services to Trangie, the Trangie Action Group would seek to become the lead tenant in the vacant Surgery in Dandaloo Street, Trangie, and to offer a low rental and easy to access facility for visiting Health professionals.

This would be undertaken on a one year trial basis to determine if the Trangie Action Group can bring improved, more frequent and more diverse health services through the offering of the Surgery space in Dandaloo Street.

The Trangie Action Group would be responsible for:

- Taking the bookings for the use of the Surgery by Health professionals.
- Maintaining the bookings diary.
- Undertaking the cleaning and garden care for the Surgery.
- Paying outgoings such as electricity and water.
- Maintaining the key system such that Trangie Action Group members would meet the casual tenant at the start of their visit, welcome them and collect keys at the end of that visit.
- Ensuring the Bona Fides of those utilising the facility including correct accreditations and insurances.

During the trial period the Trangie Action Group would charge a nominal fee for those using the facility to cover the costs of the electricity, water and cleaning.

Council would continue to insure the building and maintain the building to its current standard.

The Trangie Action Group, Trangie Community and Council would gauge the success of the trial on increased availability of health professionals, the ability to charge a more commercial rental to visiting health professionals and the overall usage that the Surgery received. If the trial proved successful then a more commercial rental might be available to be negotiated in the future.

**2. REQUEST FOR LEASE OF TRANGIE DOCTORS SURGERY- TRANGIE ACTION GROUP
(Cont'd)**

The suggested trial period is from 1 July 2019 to 30 June 2020. During the trial period all approvals for usage would first be made by the Trangie Action Group with details of usage and approvals then shared with Council.

The Trangie Action Group have two expressions of interest for usage of the facility already and are keen for the trial to begin as soon as practicable.

Financial Implications

There are no additional financial implications at this time for Council. Council has a small maintenance budget for the facility.

RECOMMENDATION

1. That Council enter into a formal agreement with the Trangie Action Group to lease the Doctors Surgery at 61 Dandaloo Street, Trangie, from 1st July 2019 to 30th June 2020, at a rental of \$1 per annum payable on demand.
2. That the Trangie Action Group sub lease the facility only to suitably accredited health professionals with appropriate insurance in place.
3. That a diary system for the sub lease of the facility be maintained by the Trangie Action Group.
4. The Trangie Action Group be responsible for electricity and water usage charges during the trial period which will be billed by Council.

INTRODUCTION

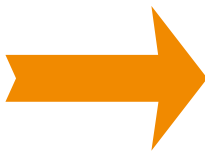
Narromine Shire Council's Social Plan identifies the aspirations, hopes and gaps within the Narromine Shire Council area that influence people's quality of life. The preparation of the Social Plan 2019-2021 has included a number of phases:

Phase 1: Developing the Community Strategic Plan



In 2016 Narromine Shire Council undertook the development of the Community Strategic Plan as part of its Integrated Planning and Reporting strategy. This plan highlighted the local community's aspirations across a number of broad themes including vibrant communities, growing our economy, protecting and enhancing our environment and proactive leadership.

During the development of this plan a detailed demographic analysis was undertaken, detailed legislative and policy analysis along with consultation of over 200 local people and community groups.



Phase 2: Social Plan 2019-2021

From the broad themes provided in the Community Strategic Plan a number of social themes have been developed that capture those wants and needs specific to the Social Plan. This Social Plan now sets out the strategic direction of Narromine Shire Council in regards to the social needs of our communities and highlights potential gaps in the delivery of services requested by the community.

The social plan provides the strategic direction for the life of Narromine Shire Council's current Delivery Plan through to 30 June 2021.

The themes contained within Narromine Shire Council's Social Plan are:



OUR COMMUNITIES

The Narromine Shire is located 40 kilometres west of Dubbo, in the Orana region of New South Wales, Australia. Covering 5224 square kilometres, our vast Shire includes the major rural centre of Narromine, as well as Trangie and Tomingley.

We are a community of nearly 7,000 residents and are proud of our heritage, history and towns that we share with our residents, businesses and visitors. We choose to live in our Shire because of its location with access to a regional centre, its picturesque setting and our close community connections.

The Wiradjuri people were the original inhabitants of this area and the traditional owners of this land. Today our Shire has an indigenous population of just under 1000 residents (21%).

Our agriculture sector has long been the mainstay and we are well known for our sheep, cattle and wool, cotton production as well as broadacre cereal crops. Alkane Resources Limited provide significant employment opportunities.

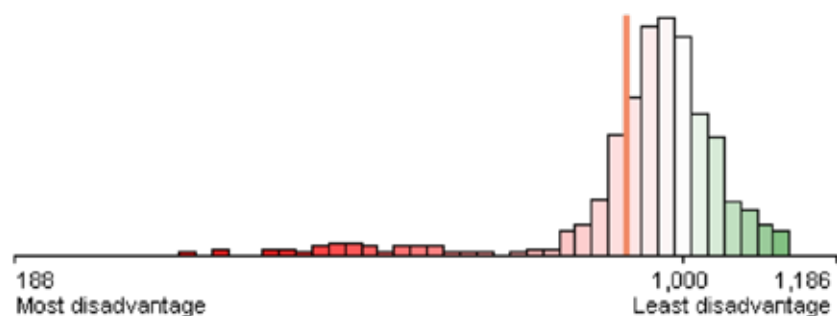
SEIFA Index of Disadvantage (2016)

The SEIFA index of disadvantage score for Narromine (A) is 933.

The SEIFA scores range from 188 (min) to 1,186 (max), with 188 having the highest level of disadvantage and 1,186 being least disadvantaged.

The local government area index of Narromine (A):

- Ranks 123 out of 544 local government areas with SEIFA scores in Australia;
- There are 421 local government areas which are less disadvantaged;
- There are 122 local government areas that are more disadvantaged.

Definition

Socio Economic Indexes for Areas (SEIFA) is a suite of indexes that have been created by the Australian Bureau of Statistics (ABS) from social and economic Census information.

Each index ranks geographic areas across Australia in terms of their relative socio-economic advantage and disadvantage. This report presents information from the Index of Relative Socio-economic Disadvantage (IRSD), a general socio-economic index that summarises a range of information about the economic and social conditions of people and households within an area. This index includes only measures of relative disadvantage.

A low score indicates relatively greater disadvantage in general. For example, an area could have a low score if there are (among other things):

- few households with low incomes, few people with no qualifications, and few people in low skilled occupations.

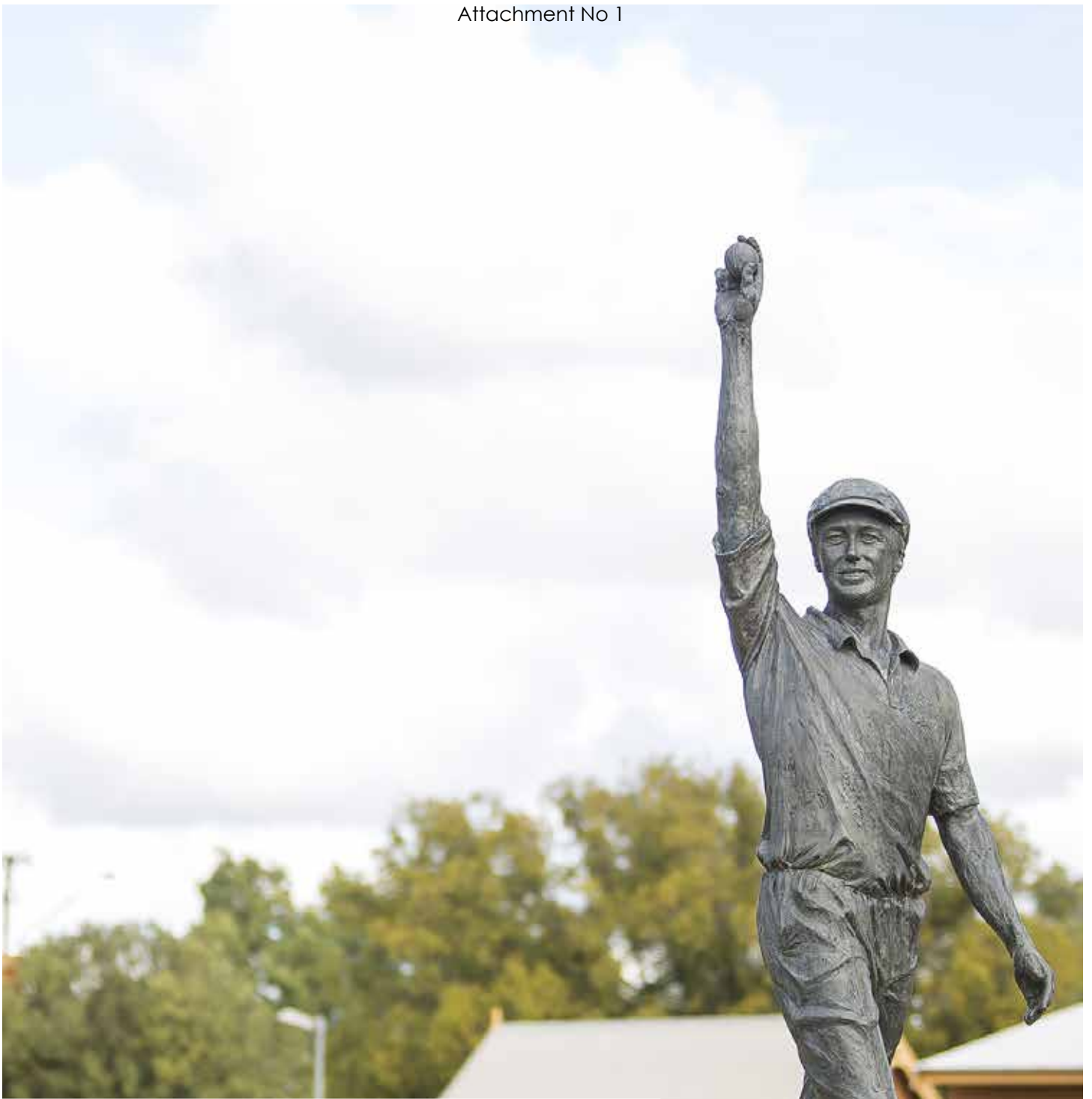
