Executive Summary

This report provides Council with an update on the levee feasibility study and preliminary feedback from community consultation recently undertaken.

Report

Council resolved at their Ordinary Meeting on 11 April, 2018 that "the report of the Narromine Floodplain Management Committee and the recommendations from the minutes of 14 March 2018 be adopted with the exception of the recommendation that Council discontinue the current process and apply for conditional funding from OEH to encompass a broader scope and investigate options for the existing railway line, for an unimpeded flow out on Webb Siding Road" and "that Option B of the report to the meeting be the recommended alignment for the proposed levee."

With a determination made on the proposed alignment of the levee bank, Council was able to undertake community consultation with regards to this. This consultation took place over two (2) days, being 26 and 27 June, 2018 and was undertaken as follows:

- Morning and afternoon sessions over a two day period, where residents booked, in 15 minute intervals, time with the consultants to discuss the impacts of the proposed levee along Option B.
- There were focus groups of River Drive, Crossley Drive and Warren Road, each allocated set time slots of availability and another time slot for those directly affected on the other side of the river.
- An information forum was held on the evening of 27 June, 2018.

Over the two (2) days, a number of residents from the focus areas attended with five (5) from River Drive, 10 from Crossley Drive and 13 from Warren Road. There was one (1) attendance from the other side of the river which may be impacted. Majority of the Warren Road residents that attended the one on one sessions also attended the information session.

Residents were encouraged to provide Council with a submission and feedback to Council with regards to the proposed levee alignment.

2. LEVEE UPDATE (Contd)

The one on one sessions began with Council providing a background on how we got to where we are, and what reports had been completed.

There was then an opportunity for residents to speak with consultants responsible for the hydraulic modelling and concept design of the levee and receive information specific to their properties. A representative from the Office of Environment and Heritage was also present.

The evening session also began with a background of the project and it was followed with a presentation from the consultant responsible for the concept design of the proposed alignment.

The evening then progressed with an opportunity for those present to ask questions which could be responded to by those present.

Now that the community consultation process has been undertaken, Council has been able to make a claim on outstanding milestone payments from the Office of Environment and Heritage grant.

Council is now receiving submissions in regards to the proposed alignment of the levee bank. These will be presented to Council when the determination of the outcome of the feasibility study is required.

Financial Implications

Council has a current budget allocation in this financial year to finalise the feasibility study on a 1:6 ratio with the Office of Environment and Heritage. Further funding has been sought in the 2018/19 grant program for the review of the Floodplain Risk Management Study and Plan that was last undertaken in 2009.

Executive Summary

The purpose of this report is for Council to consider a request for financial support to establish a Narromine Parkrun.

Report

Parkrun is a free, weekly, 5km timed run taking place in communities held at the same time every Saturday morning, all around the world. The event encourages people of all abilities, from walkers to experienced runners, to participate in a relaxed organised event with the rest of their community.

Parkrun is a not-for-profit, community event operated by a Committee of community members with weekly volunteers providing support in the form of course marshals, timekeepers, event set up, photographers and result processing. These volunteers manage the event every week under the leadership of a volunteer Event Director. Parkrun has been extremely successful in New South Wales, with over 80 communities now hosting a Parkrun every Saturday. Locally, Dubbo Parkrun has over 4,000 registered runners and rotates a roster of 10 volunteers each week.

Council's Recreational Services team has recently met with three (3) community members who have formed the Narromine Parkrun Event Team. With support from Parkrun Australia, the Committee aims to establish a suitable 5km course in Narromine. A number of our residents travel to participate in the Dubbo Parkrun. Hosting an event in Narromine will provide an opportunity for local residents to be physically active in a safe environment open to all ages, abilities, genders and fitness levels. The event aims to strengthen community connections and help to reduce the myriad of health issues associated with physical inactivity.

3. NARROMINE PARKRUN FUNDING REQUEST (Cont'd)

A 5km course has been identified in the Narromine Wetlands, which provides a scenic and interesting running route, with supporting facilities such as water and toilets on site.

To start an event, there is a one off establishment fee payable to Parkrun Australia of \$7,000 (ex GST) to fund start-up costs and equipment, including a defibrillator plus all marshalling and timing equipment.

The Narromine Parkrun Event Team has requested Council's support to establish this event through the donation of 50% of the one off start-up fee to the value of \$3,500 (ex GST).

Financial Implications

Support would result in a \$3,500 donation to establish the Narromine Parkrun. This could be funded from existing allocations within the community events budget.

Executive Summary

This report provides Council with information on the pool and gym memberships for the past financial year.

Report

Council held a workshop regarding the Sports Centre on the 18th January, 2017 and one for the Pools on 22nd March, 2017. These were productive workshops from which some actions were created. Some of these actions have been completed, with others being programmed in accordance with the budget.

A review has been undertaken of the income and expenditure of both the pools and the sports centre, with a comparison of the previous year. The results are summarised below.

Narromine and Trangie Pools

2016/17

Income \$84,363.28 Expenditure \$267,011.95

2017/18

Income \$77,830.48 Expenditure \$442,350.06

As Council is aware, Council's insurers undertook a risk assessment in 2017 and identified that supervision was required for the whole of the pool (both Narromine and Trangie). Furthermore, Council received advice from the insurers that the lifeguard could not receive gate takings, whilst supervising the pool. Accordingly, it was recommended that there should be two (2) lifeguards on duty at all times that the pools were open.

In order to accommodate the requirement of an additional lifeguard, it was necessary to reduce the opening hours of both pools.

4. POOL AND SPORTS CENTRE UPDATE (Cont'd)

As Council will appreciate, the 2017/18 pool season was of new beginnings with a fresh perspective on operations. It was identified that there were a number of pre-existing operational oversights that required attention and a copious amount of work has been undertaken to ensure that pool operations have been brought into line with industry standards. Accordingly, a significant backlog of capital and maintenance work has been undertaken which will ensure that these assets can be maintained and managed into the future with a consistent management program.

The over-expenditure is attributed to a number of factors, including:

- Contractors were engaged to fix leaks in the pool. Further issues were found that required rectification works, which cost more than what was budgeted for.
- The leaking of the pool increased water and chemical usage. As such, the cost of chemicals has also increased over what was budgeted for.
- A water meter has recently been installed and the pools have been billed for the cost of the water used to top the pool up. It is anticipated that this water consumption should be drastically reduced going forward now that the leaks have been fixed.

A comparison of patronage at each of the pools is shown in the following table:

Due to the lack of comparable data available from the previous pool season, it is difficult to provide a comparison to this year. However, it is envisaged that with the improvements being made, we will be in a better position to provide a comparison after this upcoming pool season.

The programs run at Council's pools in the 2017/18 season created \$13,938 of income and included:

- School Swimming Carnivals
- School reward days
- Dubbo Diggers Swimming Club time trials
- Learn to Swim programs
- Narromine Swimming Club programs
- Private coaching programs
- NSW Health Aqua Aerobics classes
- Centacare Women and violence program
- Centacare Light the night event
- Breakthru Disability Swimming Carnival
- NSW Royal Life Saving Bronze Medallion and Lifeguard training courses

It is anticipated that these programs will also run in the upcoming pool season.



- After School Sports Program x 2 terms

This financial year Council is also trialling indoor soccer and indoor netball. Council will be running these events, and pending participating numbers, will expand age groups. There is an opportunity for other Council run programs to continue as well, again, pending continued participation. The initial feedback received with regards to the indoor programs is very positive, it is hoped that this is reflected in the registration numbers.


