6 Incidents attended by Narromine Rescue Squad, a good response from all other agencies involved.

Multi Agencies exercise being planned by VRA Rescue NSW. Details to be provided to Inspector Russell once confirmed.

#### (c) NSW Rural Fire Service (Mark Pickford)

55 call outs – majority burnt out motor vehicles. Grass Fires still a reasonable fire risk. Servicing program has commenced. New training prop in Dubbo.

#### (d) NSW Police Orana – Narromine (Inspector William Russell)

Staffing is currently at full strength including Trangie. Keith Ridley is now officer in charge for Trangie and Warren. Inspector William Russell to look after Narromine LGA. Rural Crime Investigation taskforce has a number of targets to be followed up, search warrants have been conducted. Direct all concerns to the Police.

#### (e) Local Land Services LLS (Jason Gavenlock)

Concern with the amount of dry feed about, this poses a fire hazard. Slashing has been completed to reduce this. There are stock (cattle) on the road, stock to be brought in to eat around the Trangie Silo.

#### (f) Transport for NSW (David Dickey)

RMCC – (Roads Maintenance Council Contracts) Tomingley-Eumungerie Road was nominated for transfer back to the State. TfNSW as an owner of the road has awarded Narromine Shire Council contract to carry out maintenance work under Road Maintenance Council Contracts.

Culling and Manildra Streets – are currently in the process of being handed back to TMC (Transport Management Centre).

- 6. Feedback from REMC members provided to LEMC
- 7. Updates and changes are made based on feedback
- 8. EMPLAN is endorsed and signed by REMC chair and LEMO. EMPLAN can now be used as the endorsed version and is valid for 3 years from the date of endorsement.

#### 2023 Menindee Fish Kill Event

On the 17<sup>th</sup> of March 2023 the Department of Planning and Environment identified a large fish death event upstream of Lake Menindee. This is the largest event of its kind in recorded history and was approximately 20 times the size of the fish death event in a similar region in 2018.

Due to the scale and complexity of the event the Central Darling local EOC was opened on the 18<sup>th</sup> of March at the Menindee Police Station. The intent of this EOC was to understand the impact of the event on the local community and work to manage these impacts.

It was clear from the first EOC briefing that this event was complex and of a scale not previously experienced within this community. As a result, 4 working groups were established to address the initial main concerns identified. These working groups were

- 1. Management of the fish carcases
- 2. Water quality monitoring for drinking and household use
- 3. Options for potable water transportation for humans and livestock
- 4. Community engagement and consultation

Each working group was designated a leader and 3 team members from the relevant agencies and functional areas. These groups had further oversight from the Incident Controller to ensure that objective were met in the designated timeframe.

At established times the working groups would brief the EOC on their recommendations and plan of action moving forward. This approach allowed for concise EOC briefings while giving the individual challenges enough resources and attention to be appropriately addressed.

The agencies involved in this event included the NSW Police Force, Central Darling Shire, Department of Planning and Environment, Environmental Protection Authority, Essential Water, Department of Primary Industries (Fisheries), Local Land Services, Reconstruction Authority, Water NSW, Murray Darling Basin Authority, Aboriginal Affairs, NSW Health, Fire and Rescue NSE, Wentworth Shire Council LEMC, Department of Communities and Justice (Welfare) and National Parks and Wildlife.

# NSW Reconstruction Authority Central West, Orana and Far West (CWOFW) Report - Local Emergency Management Committee

Tuesday, 18 April 2023

#### NSW Reconstruction Authority

In Western NSW, coordinated recovery efforts continue in flood-impacted communities, and temporary housing options (pods and at-home caravans) are being rolled out. Bushfires have impacted communities in the West and Far West of the state.

Regional Recovery Coordinators for the impacted regions are overseeing recovery efforts; Dean Betts, for the North Coast and North West, Ken Harrison for the Central West and Linda Thomas for the Riverina Murray.

#### **Recovery Assistance**

Recovery Assistance Points (RAPs) continue to be coordinated by NSW Reconstruction Authority, to offer face-to-face support for disaster-impacted households, businesses and landholders.

The total number of people that have attended RAP's is 2978 across the Central West and Far West. RAPs continue in the following locations following flood and storm events from September 2022 onwards:

- Eugowra
- Forbes

RAPs were conducted in the following locations following bushfire events March 2023:

- Hargraves
- Windeyer
- Hill End

#### Alpha Road Tambaroora Fire

18,000ha of agricultural grazing land, large parcels of land reserved for hunting, smaller lifestyle and hobby farms have been impacted.

- 6 x homes destroyed
- 4 x homes damaged
- 13 x outbuildings destroyed
- 16 x outbuildings damaged
- 587 x stock euthanized
- 255km fencing damage estimates

#### Menindee Fish Kill

The Menindee fish kill (Hypoxic blackwater event) was a NSW Police operation and an Emergency Operations Centre was stood up which dealt with a number of issues including water supply which was not interrupted.

EPA and PWA worked well together to harvest dead fish.

The blackwater event moved down stream between Pooncarie and Wentworth with an EOC stood up at Wentworth Balranald.

There were around 20 million plus fish killed, largely bony brim.

This event is not uncommon after a flood event, and there will be a review to find the causes of this event.

NSWRA continue to work closely with Police and Central Darling Shire regarding potable water supply to some residents.

#### Pre-Event Recovery Plan

NSWRA staff will be supporting Councils in their development of their Pre-Event Recovery Plan, to be endorsed by your Local Emergency Management Committee.

The Pre-Event Recovery Plan is a guiding document developed to aid local government and communities prepare for effective responses to natural disasters.

This includes identifying all the government, non-government and community services who will be required to drive the initial establishment of recovery supports in the aftermath of an event.

#### Executive Summary

The purpose of this report is to obtain comment and endorsement of the proposed traffic signage to be added in and around the Return and Earn Facility to be established at the Narromine Waste Depot.

#### Report

In April 2022 Council endorsed a proposal for a Return and Earn vending machine to be established in Narromine using an area made available adjacent to the Narromine Waste Depot.

An analysis by TOMRA had shown that it would be possible to install a reverse vending machine adjacent to the waste facility and the general layout was developed to be as shown below.



The general layout includes a container, two parking bays (disability access compliant) and an area to the back of the container where the skip bin can be taken from to be emptied.

The facility will look similar to the example below and it is expected that approximately 20-30 people will access the facility each day. Note that the usage will be monitored to ensure no further enhancements are required.



### Signage

There are existing stop signs at the intersection of the waste facility entrance and Gainsborough Road and also Gainsborough and Tomingley Road.

It is recommended that following additional signage be placed inside the waste depot facility along the formed entrance.

- No parking sign from the entrance to the locked gate (facility entrance) to the container parking.
- Disability parking sign be added to the disability parking space.
- No parking sign adjacent to the neighbouring property owners access.
- Upgrade the place marking sign to include location of return and earn facility.

#### Executive Summary

The purpose of this report is to obtain comment and endorsement of the proposed traffic signage to be added in and around the Level Crossing, Dandaloo Road and Backwater Road.

#### Report

In April 2023 Council was approached by TfNSW with regards to the potential of an advanced warning signage trial at the level crossing located on Old Backwater Road, Narromine. TfNSW anticipate installation of warning signage for July/August.

During their site visit, they have noticed that the Advanced Warning sign showing a Stop Sign ahead on Dandaloo Road westbound was faded and may need to be replaced. TfNSW are requesting that Council replace this faded sign at their earliest convenience with a new Stop Sign Ahead Advanced Warning Sign.

Old Backwater Road – is a Stop Sign Ahead Advanced Warning Sign that is not at the stipulated 190m distance as required by the standard, but only 100 metres distance. TfNSW are requesting that Council relocate this sign from 100m to 190m from the level crossing as required by the standard.

Lastly, Wingfield Road, near the intersection with Old Backwater Road, there should be in place a W7-17R sign indicating a level crossing at the right of the upcoming T intersection as per the standards.

TfNSW are willing to accommodate and reimburse Council for their efforts with the requests to upgrade and move the signs.


