#### **AUSTRALIA DAY 2021**

Narromine residents are reminded that due to COVID restrictions there will be changes to the usual **Australia Day activities in 2021**.

The Council led Australia Day ceremony will be held in **Narromine** as an **invitation only** civic event and citizenship ceremony.

Community members and interested people are invited to participate via a livestream on **Narromine Shire Council's Facebook page from 8.30 am** on Tuesday 26<sup>th</sup> January 2021.

**Trangie Action Group** will hold an **Australia Day ceremony** at the Trangie USMC commencing at **6.00 pm in Trangie**.

EXTENDED SCHOOL HOLIDAY HOURS AT NARROMINE AND TRANGIE AQUATIC CENTRES Narromine and Trangie Aquatic Centres will have extended pool hours during the 2020/2021 Summer school holiday period effective from 21 December 2020 through to 29 January 2021.

**Entry fees to both Narromine and Trangie Aquatic Centres** will be **half price** from Saturday **16 January** through to Thursday **4 February 2021**. Entry fees are subsidised by NSW Government and apply only to a daily admission fee, non-swimming admission fee and swimming carnival spectator fee.

Please be advised that Narromine and Trangie Aquatic Centres will be **open** from **10.00 am to 6.00 pm** on Australia Day (Public Holiday) **26 January 2021**.

## **MAJOR PROJECTS**

Council would like to advise of the following major projects that are currently on public exhibition:

**Inland Rail - Narromine to Narrabri** proposed by Australian Rail Track Corporation Limited. The Proponent has requested the Minister for Planning and Public Spaces to declare the proposal as critical State Significant Infrastructure.

This section of the Inland Rail project consists of approximately 300 km of new single-track rail line, through private and public property in a "greenfield" environment between Narromine and Narrabri.

The State Significant Infrastructure (SSI) application, Environmental Impact Statement (EIS) and accompanying documents are on exhibition until **Sunday 7 February 2021** and are accessible electronically on the Department's website <a href="https://www.planningportal.nsw.gov.au/major-projects/project/10211">www.planningportal.nsw.gov.au/major-projects/project/10211</a>

**Tomingley Gold** (Alkane Resources Ltd) have submitted a Modification Report and Appendices for Tomingley Gold MOD 5. The Department of Planning, Industry and Environment is aiming to have the Modification on exhibition **Wednesday 16 December 2020** to **Friday 29 January 2021**.
