COVID-19 UPDATE - NARROMINE SHIRE COUNCIL BUILDINGS

Based on current Public Health Orders, please be reminded that **ALL VISITORS** are requested to sign in through the **QR code** and **face masks must be worn** when visiting Narromine Shire Council's Customer Service and Payments Centre, Council Chambers, Narromine Sports and Fitness Centre, Macquarie Regional Library Branches of Narromine and Trangie.

All members of the Narromine Sports and Fitness Centre are REMINDED to sign in through the QR code, wipe each piece of equipment down after use and remain 1.5 m distance from others. It is mandatory for face masks to be worn if not partaking in strenuous physical activity, this includes moving between equipment, entering and exiting the facility.

NARROMINE WETLANDS CLOSED TO ALL VEHICLES

Council advises all residents that the Narromine Wetlands is closed to **all vehicles** as construction of the first primary pond is underway. **Pedestrians** are able to access the Wetlands via the pedestrian gate near the public toilets. Pedestrians are advised to enter the Wetlands with caution, as internal walkway closures will occur. For your safety, please observe all signs in place.

CLOSED ROADS AND ROAD SAFETY REMINDER

Council advises that the following roads remain **CLOSED to ALL VEHICLES**Gainsborough Road (between Tomingley Road and McGrane Way) – access to Narromine Waste Depot remains unaffected, Merrinong Road (between Pineview Road and Ewenmar Road), McLeod's Lane, Pineview Road, Tyrie North Road, Belowrie Road and Momo Road.

Tomingley Road and Eumungerie Road are CLOSED to all vehicles over 10 tonnes.

The remainder of all unsealed roads in the Shire are OPEN to all vehicles. All motorists are reminded not to drive through floodwaters and proceed with caution on all other roads.
