### NEXT COUNCIL MEETING – 25 AUGUST 2021 LIVESTREAMED

The next Ordinary Council meeting will be held on **Wednesday 25 August 2021**. Due to current **COVID-19 Public Health Orders** the meeting will be held via audio visual link commencing **at 5.30 pm**. This meeting will be livestreamed with an audio recording uploaded on to Council's website thereafter. This meeting will consider the business items of Council's Extra Ordinary Meeting that was scheduled to take place on 28 July 2021 and Council's Ordinary Meeting that was scheduled to take place on 11 August 2021.

### WALK-IN COVID-19 VACCINATION CLINICS - NARROMINE / TRANGIE / PEAK HILL

Western NSW Local Health District is partnering with the Australian Defence Force and will be conducting Pop-Up COVID-19 Vaccination Clinics in Narromine and Trangie. These are walk in clinics and no appointments are necessary, however a form of identification and a Medicare card will be required.

**Narromine's walk-in Vaccination Clinic** will be held at Narromine Sports and Fitness Centre, 12A Meringo Street Narromine on Wednesday 25 and Thursday 26 August from 10.00 am to 4.00 pm each day.

**Trangie's walk-in Vaccination Clinic** will be held at Trangie Memorial Hall, 56 Dandaloo Street on Friday 27 August from 11.00 am – 4.00 pm and Saturday 28 August 9.00 am to 3.00 pm.

**Peak Hill's walk-in Vaccination Clinic** will be held at Carrington Hotel, Caswell Street Peak Hill on Friday 27 August from 11.00 am – 4.00 pm.

### Eligibility for vaccines at this clinic will be as follows:

12 years and over - for people who are Aboriginal or Torres Strait Islander or have a significant underlying medical condition or disability.

16 years and over - for people from the general population.

The queue may be long, so we encourage people to come prepared with food, drink, a hat & sunscreen. Second dose clinics will be conducted three weeks later.

### People must not attend the clinic if they:

Are waiting on a COVID-19 test result.

Are a CONFIRMED close contact of a CONFIRMED positive COVID-19 case.

Are unwell. Anyone with COVID symptoms should get tested & isolate until they receive a negative test result.

Have had ANY other vaccination (including flu) in the previous seven days.

## **STAY AT HOME ORDERS APPLY TO NARROMINE LGA**

As of 7.00 pm Wednesday 11 August 2021 **Stay At Home** orders apply to people who live in or are temporarily staying in the **Narromine Shire Council** Local Government Area (LGA) or have been there on or after 5 August 2021 (the Narromine LGA is inclusive of Narromine, Trangie and Tomingley).

What the **Stay At Home** orders mean to all residents - People must only leave home for essential reasons:

- locally (within your local government area (LGA) or, if outside of your LGA, within 5km of your home from 12:01am Monday 16 August). You may travel beyond this area if the goods or services are not reasonably available locally
- only one person per household may leave home to shop each day, and browsing in shops is not allowed
- seeking medical care (including COVID-19 testing or getting vaccinated), for an emergency or a compassionate need
- exercising outdoors with one other person within 5km of home or LGA
- essential work or education, where you cannot work or study from home.

When leaving home for essential reasons, anyone over 18 years of age must carry photo identification with evidence of their home address, such as a NSW Photo Card or Drivers Licence, and produce it to a police officer on request.

In addition:

- Face masks are compulsory in all indoor non-residential premises, public transport and all outdoor settings
- Visitors to households is not permitted unless you need care (including personal care)
- If you are 16 years and over, get vaccinated as soon as possible.

Remember, it is vital for anyone showing any symptoms, or those who are a close or casual contact of someone who has tested positive to COVID-19, to get tested immediately, stay home and follow the health advice.

### **NARROMINE, TRANGIE AND TOMINGLEY WATER METER READING**

Residents of Narromine, Trangie & Tomingley are advised that Council will be conducting water meter reading from Monday 30<sup>th</sup> August to Wednesday 1<sup>st</sup> September 2021.

Please ensure water meters are accessible and animals/pets are secured during this period. If your meter cannot be accessed, Council will estimate your water usage based on the previous usage. The Meter Readers will be following all COVID safe

protocols in addition to standard safe work practices. Water Meter readers have weekly COVID tests and will be carrying official correspondence indicating they are essential workers.

### **LOCAL GOVERNMENT ELECTIONS POSTPONED UNTIL 4 DECEMBER 2021**

Council advises that NSW Government has postponed the NSW Local Government Elections that were to be held on 4 September 2021 until **Saturday, 4 December 2021**, due to the escalating COVID-19 situation. The current Narromine Shire Councillors will continue to hold their civic offices until this time. ### **NARROMINE WETLANDS CLOSED TO ALL VEHICLES**

Council advises all residents that the Narromine Wetlands is closed to **all vehicles** as construction of the first primary pond is underway. **Pedestrians** are able to access the Wetlands via the pedestrian gate near the public toilets. Pedestrians are advised to enter the Wetlands with caution, as internal walkway closures will occur. For your safety, please observe all signs in place.

### **CLOSED ROADS AND ROAD SAFETY REMINDER**

Narromine Shire Council wishes to advise that due to recent rain, all **UNSEALED ROADS** in the Shire are now **CLOSED** to all vehicles. The following roads will remain **CLOSED to ALL VEHICLES** - Gainsborough Road (between Tomingley Road and McGrane Way) – access to Narromine Waste Depot is not affected, Merrinong Road (between Pineview Road and Ewenmar Road), McLeod's Lane, Pineview Road, Tyrie North Road, Belowrie Road and Momo Road.

All motorists are reminded not to drive through floodwaters and proceed with caution on all other roads. Council reminds all motorists to check Council's website, social media and LiveTraffic app or call 132 701 for information on local roads and traffic. ## **MAGPIE SEASON IN THE NARROMINE REGION**

Residents are reminded that it is peak magpie breeding season and they are actively protecting their nests over the next few months. Please be aware that magpies will swoop walkers, runners and bike riders, presently they are very active at the Narromine Cemetery.

Magpies are native species to the Narromine Region and are protected species throughout NSW. Large fines and jail terms apply to offenders who kill, harm or capture the birds. Problems experienced with swooping magpies may be reported to WIRES (13 000 WIRES or 1300 094737) or to the National Parks and Wildlife Service (02 9585 6333). ## **NARROMINE SHIRE COUNCIL'S VANDALISM REWARDS SCHEME POLICY**

Council reminds residents of the VANDALISM REWARDS SCHEME POLICY that is in place to try and minimise the **costs of vandalism** where the community is encouraged to report vandalism.

**This policy offers a reward (maximum of \$5,000)** to persons providing information on vandalism to Council owned or managed property that results in legal action being taken - i.e. criminal proceeding resulting in a conviction, finding of guilt or offence; formal caution/warning issued by a NSW Police Force Officer; or a juvenile justice conference administered under the Young Offenders Act 1997.
