MAGPIE SEASON IN THE NARROMINE REGION

Residents are reminded that it is peak magpie breeding season and magpies are actively protecting their nests over the next few months. Please be aware that magpies will swoop walkers, runners and bike riders. Magpies are very active at the Narromine Cemetery – please enter with caution.

Magpies are a native species to the Narromine Region and are a protected species throughout NSW. Large fines and jail terms apply to offenders who kill, harm or capture

the birds. Problems experienced with swooping magpies may be reported to WIRES (13 000 WIRES or 1300 094737) or to the National Parks and Wildlife Service (02 9585 6333). STAY AT HOME ORDERS APPLY TO NARROMINE LGA

As of 7.00 pm Wednesday 11 August 2021 **Stay At Home** orders apply to people who live in or are temporarily staying in the **Narromine Shire Council** Local Government Area (LGA) or have been there on or after 5 August 2021 (the Narromine LGA is inclusive of Narromine, Trangie and Tomingley).

What the **Stay At Home** orders mean to all residents - People must only leave home for essential reasons:

- locally (within your local government area (LGA) or, if outside of your LGA, within 5km of your home from 12:01am Monday 16 August). You may travel beyond this area if the goods or services are not reasonably available locally
- only one person per household may leave home to shop each day, and browsing in shops is not allowed
- seeking medical care (including COVID-19 testing or getting vaccinated), for an emergency or a compassionate need
- exercising outdoors with one other person within 5km of home or LGA

- When leaving home for essential reasons, anyone over 18 years of age must carry photo identification with evidence of their home address, such as a NSW Photo Card or Drivers Licence, and produce it to a police officer on request.

In addition:

- Face masks are compulsory in all indoor non-residential premises, public transport and **all outdoor settings**
- Visitors to households is not permitted unless you need care (including personal care)
- If you are 16 years and over, get vaccinated as soon as possible.

Remember, it is vital for anyone showing any symptoms, or those who are a close or casual contact of someone who has tested positive to COVID-19, to get tested immediately, stay home and follow the health advice.

NARROMINE SHIRE COUNCIL'S RESPONSE TO COVID-19

To align with the NSW Government's Stay at Home Orders and to protect Council staff a number of Council businesses and services are closed or operating under various restrictions until further notice.

Closures include Narromine Shire Council Chambers, Customer Service and Payments Centre, Narromine Aviation Museum and Visitor Information Centre, Narromine Library, Trangie Library and Narromine Sports and Fitness Centre. Residents are still able to contact Council on 6889 9999 between business hours 8.30 am to 5.00 pm. The following **Council essential services** such as water, sewer, roads, ranger (emergency work), waste and amenities cleaning continue to operate effectively.

Replacement green bin liners are available out the front of Council's Customer Service & Payments Centre Office. Alternately please call 02 6889 9999 and Council's Customer Service staff can arrange for delivery by JR Richards. Payment of accounts can be made over the telephone, internet, Australia Post agencies or by contacting your financial institution. COVID -19 TESTING CLINICS IN NARROMINE AND TRANGIE

Council advises residents that **NSW Health** is conducting a drive-through COVID-19 testing clinic at Narromine Showground from 9.30 am through to 2.30 pm each day. NSW Health runs a testing clinic at Trangie's MPS call 5881 9200 to secure an appointment. Surveillance testing is now activated across the Western NSW Local Health District and this allows residents to be tested and not have to self-isolate after the test is conducted - unless you have symptoms; you have been directed to isolate by NSW Health or have been at a venue of concern or someone in your household is a close contact of a confirmed COVID – 19 case.

BE A RESPONSIBLE PET OWNER

Pet owners are reminded to microchip and register their dog or cat and ensure that their contact details are up to date. Any person wishing to register a cat or dog can do so by phoning Council on 6889 9999. All impounded animals must be microchipped and registered before being released from Council's pound.

Please remember as a pet owner, it is the owner's responsibility to ensure all pets are healthy, safe, well cared for and do not create a nuisance in the neighbourhood. Council operates a leash free area for dogs at the eastern end of Rotary Park on Culling Street Narromine.

A reminder that all people in charge of a dog must take all reasonable precautions to prevent dogs from escaping the property it is being housed in. Cat owners are always encouraged to keep a cat indoors at night to help reduce the number of native wildlife that are injured and/or killed and for other benefits such as cat fighting. CLOSED ROADS AND ROAD SAFETY REMINDER

Narromine Shire Council wishes to advise that the following roads will remain **CLOSED to ALL VEHICLES** - Gainsborough Road (between Tomingley Road and McGrane Way) – access to Narromine Waste Depot is not affected, Merrinong Road (between Pineview Road and Ewenmar Road), McLeod's Lane, Pineview Road, Tyrie North Road, Belowrie Road and Momo Road.

All motorists are reminded not to drive through floodwaters and proceed with caution on all other roads.
