### **DAPPO ROAD CONSTRUCTION - CHANGES TO TRAFFIC**

Council advises the community that construction will commence on an upgraded culvert crossing under **Tomingley Road** for the Dappo Road and Timbrebongie Subdivisions. These works are being undertaken by Robson Civil Projects. **Tomingley Road** will be reduced to a single lane carriage way with temporary traffic light contraflow system. Traffic signage will be installed to inform road users of the changes to the road

conditions. The works are scheduled to be carried out weekdays during the hours of 6.30 am - 5.00 pm and on Saturdays 8.00 am until 4.00 pm (where required). Robson Civil expects the works to be completed by late July 2022 (weather permitting).
